**PAYMENTS/LOANS TO DIRECTORS AND RELATED PARTIES AND ASSOCIATES OF**  
**DIRECTORS AND RELATED PARTIES OF GRANGE RESOURCES LIMITED**

Payments and loans during the quarter to directors and related parties, and associates of directors and related parties, of Grange Resources Limited total \$251,000 and include:-

- Directors' fees (inclusive of superannuation) of \$24,000 paid to non-executive directors of the Consolidated Entity.
- Fees of \$60,000 paid to Hagankellar Pty Ltd, a company associated with a former executive director of the Company, for the provision of services of the former Managing Director at commercial rates (\$20,000 of this amount relates to services provided in the previous quarter).
- An amount of \$150,000 was paid to Hagankellar Pty Ltd in connection with the termination of the arrangement for the provision of services of the former Managing Director.
- Executive directors' salaries (inclusive of superannuation) of \$17,000.
